Dear supporter,

We hope this letter finds you well, energized by a great summer and ready to mobilize with us!

We are really looking forward to the next phase of our Lenten campaign, *Create Hope – Stand for the Land.* This time, we will meet Honduran communities whose water and land are threatened by an open-pit iron mine. Operating on a dubious permit in *Montaña de Botaderos Carlos Escaleras National Park*, the mine affects villages along the Guapinol and San Pedro rivers and the entire regional ecosystem.

Since 2018, environment and human rights defenders have courageously spoken up to denounce the mining project, which is poisoning the waters on which their livelihoods depend. Their peaceful mobilization has not been without setbacks. Some of them, now famed as the Guapinol Eight, were unfairly detained for 914 days. Three defenders have even been murdered since January 2023!

We are therefore asking you to act in solidarity with these communities. Please sign our letter to the Honduran ambassador to Canada, which presses the Honduran government to:

- → Bring the killers of the martyred defenders to justice.
- → Recompense the Guapinol Eight and their families.
- → Close the mine and restore the national park.
- → Heed and more effectively protect the country's environmental and human rights defenders.
